January Services at St Mary's Friston

Sun 7th Jan at 10am, Feast of the Epiphany/Baptism of Jesus. We celebrate these two feast days with a Service of Holy Communion (Common Worship) led by Revd. Sarah du Boulay.

Sun 14th Jan at 10am, the second Sunday after Epiphany - Service of the Word led by our Elder, Marie Szpak. Sun 21st Jan at 10am, the third Sunday after Epiphany - Holy Communion Service (Common Worship) led by Revd. Nicky Winter.

Sun 28th Jan at 10am, the fourth Sunday after Epiphany/Candlemas - Service of the Word led by Revd. Mary Brown.

Energy Projects Update

Scottish Power/National Grid - the SASES Court of Appeal hearing, challenging the decision of the Secretary of State to grant development consent, took place on 6th December before three Lord Justices of Appeal. SASES had two grounds of appeal, one related to flood risk and the other to cumulative impact. The Lord Justices indicated that judgement would be given in January 2024. The SEAS appeal relating to Scottish Power's conduct towards landowners is due to be heard in early February.

National Grid Sealink - the statutory consultation period closed on 18th December. A village meeting was held on 2 December by the Parish Council to inform residents of these proposals and to give some more insight as to the implications for Friston. It is hoped that as many residents as possible have responded to the consultation. The Parish Council with the assistance of SASES submitted a response and this is available on the Parish Council

website. Prior to this the Parish Council met with representatives of National Grid and made a number of the points in its response directly to those representatives. The Parish Council is concerned with the quality of the consultation process not least because of the seven representatives of National Grid who attended that meeting not one had read the non-statutory consultation response which the Parish Council submitted in 2022. The Parish Council intends to pursue this matter further with East Suffolk Council and Suffolk Council as they have a role in respect of the quality of consultation.

National Grid expects to make its formal development consent application in the Autumn of 2024. Recent news is that two new offshore windfarm projects, North Falls and Five Estuaries, will connect offshore to Sealink. Further details are awaited.

National Grid Lionlink - a non-statutory consultation was held in 2022 and there was a supplementary nonstatutory consultation relating to a different landfall and cable route route in Walberswick and Southwold earlier this year. Reading the small print it is clear that this project has been delayed by one year with another statutory consultation and development consent application expected in 2025.

The Parish Council has complained to the Planning Inspectorate, East Suffolk Council and Suffolk County Council about the multiplicity of development consent consultations and applications and the intolerable burden this places on the community.

National Grid Nautilus - National Grid has been considering whether it can connect this project at an existing substation location at the Isle of Grain in Kent or as originally planned at Friston. The position has still not been confirmed although a decision on this can be expected in 2024.

Community Benefits - Government, in an attempt to address the widespread opposition to multiple uncoordinated onshore energy infrastructure projects, has been consulting on a community benefits package. This has been reported in the press. The precise details are awaited but the headlines are that people close to new energy infrastructure will directly receive £1000 a year for 10 years. There will be a community payment of £200,000 for each substation. Precise details are awaited as it is unclear how this will "benefit" residents.

Sizewell C - TASC with the support of Stop Sizewell C and others is challenging the Secretary of State's decision grant development consent. The Court of Appeal hearing took place in November. The appeal relates to the availability of a potable water supply at the site and the need for a desalination plant. Judgement should be given shortly. As residents will have noted EDF is ploughing ahead with a variety of preparation works.

Friston Allotment Association

Ventilate greenhouses on mild days to help prevent grey mould (botrytis) developing on plants. Protect new shoots on peaches with polythene to prevent the spread of the rain borne disease peach leaf curl. Seed potatoes & onion setts will be available in shops this month. Early potatoes can be placed in trays to chit for an earlier crop. Gooseberries & currants can be pruned, removing a third of old wood at ground level along with any weak growth. Cover rhubarb with large pots or buckets now to get an early picking of tenders shoots in the spring. Take care when putting salt on paths in frosty weather, try to keep it away from plants & soil.
